Owner / harbourer requirements for an Intact Permit									
❖ Must be at least 18 years of age									
❖ Have a history of compliance with the requirements of the Animal Control By-Law									
❖ Have a minimal impact on the community									
❖ Provide a letter from a licensed veterinarian supporting the breeding of the specific dog or cat or proof of purebred breed registration									
❖ Submit to an inspection of the breeding property									
<i>Breeding Property:</i>									
➤ Clean and Sanitary Conditions				➤ Ample room for enrichment					
➤ Little or no animal-related odors				➤ Wholesome food and water					
<i>The Animal must:</i>									
➤ Receive active veterinarian care, including current rabies vaccination									
➤ No violations for running at large									
➤ Has not been designated a Dangerous Animal; Part 5									
➤ No violations for Impoundment
